

## Executive Director Position Available - Apply by October 17, 2014



The Central Florida Expressway Authority (CFX), a special independent district of the state, is responsible for the construction, maintenance and operation of toll roads in Seminole, Lake, Osceola and Orange Counties, and may also acquire, construct and equip rapid transit, trams and fixed guideways within the rights of way of the expressway system. The 109 mile expressway system includes the Beachline (SR 528); East-West Expressway (SR 408); Central Florida Greeneway (SR 417); Western Beltway (SR 429); John Land Apopka Expressway (SR 414) and SR 451. CFX is currently completing the beltway around Orlando in partnership with the Florida Department of Transportation; a project known as the Wekiva Parkway™. CFX's FY 2015 O&M budget is approximately \$53.5 million and the adopted 5-Year Work Plan is \$1.156 billion. There are 63 authorized full-time equivalent Agency employees. Much of the Authority's work is performed through professional services contracts. CFX's current bond ratings are: Standard & Poor's A; Fitch A; and Moody's A1.

The governing board is composed of nine members, consisting of: (a) one member each appointed by the respective chairs of the county commissions of Lake, Orange, Osceola and Seminole Counties; (b) three citizens appointed by the Governor; (c) the Mayor of Orange County; and (d) the Mayor of the City of Orlando.

The Board is looking for an Executive Director to join the team. The Executive Director is the chief administrative officer of CFX and has the power to transact business for the agency within established policy guidelines. The Executive

Director is responsible for the overall leadership and management of CFX and is the primary contact with the community. The Executive Director develops and implements programs and strategies approved by the Board of Directors to meet quantifiable goals. The Executive Director reports to the Board of Directors and works closely with the Board, its standing committees and CFX staff (and contractors) to ensure that the mission and vision are clearly defined and followed, that the organization remains fiscally sound and that it maintains the highest ethical standards.

Job requirements include graduation from an accredited college or university with a Bachelor's Degree combined with at least eight (8) years of comprehensive executive management and/or finance experience. A Master's Degree is preferable. Some experience in one or more of the following areas is desired: toll operations, fixed guideway facilities, transportation operations, budgets, business, contract management, finance, and economic development.

A successful candidate should have excellent written and oral communication skills; a strong customer service focus; proficiency with information technology; ability to read, analyze, and interpret various documents including, but not limited to, legal documents and financial statements; ability to interact, negotiate, represent, and counsel with governmental bodies, organizations, and associations at the local, regional, state, and national levels; and a commitment to full transparency.

CFX is offering a competitive salary and benefits package commensurate with experience.
